Chief Pine also mentioned he secured a DNR grant to help purchase 5 new sets of bunker gear using the balance of the Sault Tribe 2% Fall Grant.
 - i. Purchase two new breathing masks Chief Pine mentioned that we need to purchase two new breathing masks because the ones available are too large, Clerk Garlitz made a motion to purchase the two masks and not to exceed \$1550, seconded by Trustee Dickey, passed 5/0
