a. Discussion: Sugar Island vs Hann After a discussion with the board members and information provided by Township Attorney Cannello was presented, Trustee Noble made a motion to dismiss the Case: Sugar Island vs. Hann, seconded by Trustee Moher, Supervisor Roy called for a Roll Call vote: Trustee Moher, yes, Trustee Noble, yes, Clerk Garlitz, yes and Supervisor Roy, no, Motion passed 3/1 Clerk Garlitz to inform Attorney Cannello of the results of the decision.

#### 8. New Business

- Tax Levy Resolution 2020 Winter Tax Request Clerk Garlitz explained the amounts to be levied were approved at the March 28 State of the Township Meeting where the 2020-2021 Budget was approved 5/0.
- b. Clean Up Dumpsters Report Clerk Garlitz explained that the Solid Waste Dumpster's had exceeded the amount spent in previous years, but requested the board to decide if they should continue thru the month of September. Trustee Noble made a motion to continue the Clean Up dumpsters thru the end of September, Seconded by Trustee Moher, passed 3/1
- c. Ambulance Report Co Capt. Beckham explained they had 5 runs in August, and already 2 for September, Covid-19 protocols are being followed.
  - Hire LSSU Student Maxwell Sawickyj Co Capt Beckham gave a short presentation about the new EMT's qualifications. Clerk Garlitz made a motion to hire Max Sawickyj, seconded by Trustee Noble, passed 4/0
- d. Fire Department Report Chief Pine Noted they went on 2 fire calls, training has been on hold due to pandemic and Chief Pine participated in the Boat rescue on Lake George.
  - i. Presentation from Dave Pine and Representative from CSI Emergency Apparatus, LLC regarding the purchase of a new Fire Pumper/Tanker Truck. Supervisor Roy thanked them for the report, and then made a motion to table this discussion until the new Township Board is in place after the November 3<sup>rd</sup>, seconded by Trustee Noble, passed 4/0
- e. Planning Committee Report Meetings have been put on hold until after the Nov. 3<sup>rd</sup> Election and a new Board is in place.
